VOLLEYBALL WA PLAYER AGREEMENT FORM

(Please note to play in any Volleyball WA competition you must sign this agreement)

The above-mentioned person hereby agrees to the following terms & conditions upon participating in any Western Australian Volleyball Association programs:

- The player ensures that they are in good health to participate in any Volleyball WA program and hereby assumes total responsibility for any health problems that may occur. The players undertake to take out their own insurances in relation to all and any matters arising from participation in the tournament sanctioned by Volleyball WA (hereafter VWA).
- The player agrees to be bound by the AVF Anti-Doping policy and by the WADA (World Anti-Drug Agency) Anti-Doping policies as in force from time to time.
- As a registered member of Volleyball WA I undertake at all times to represent myself in a way that will not bring myself, Volleyball WA, Australian Volleyball Federation or the sport of volleyball as a whole in disrepute. I accept that failing to abide by this determination could led to sanctions as outlined in the VWA's Misconduct Code (copy available upon request at VWA office).
- The player hereby for himself/ herself, his/ her heirs, executors and assigns irrevocably release VWA from all and any claims, actions, suits and proceedings whatsoever which he/she might have arising out of death, personal injury, property damage or other loss whatsoever suffered or incurred in connection with these Terms & Conditions. The release hereby given shall operate separately in favour of all persons, corporations and bodies involved and otherwise engaged in performing these Terms & Conditions and in promoting or staging events and the servants and agents of all of them.
- The player indemnifies and agrees to hold and keep indemnified VWA from all claims, actions, suits and proceedings whatsoever arising out of the wrongful actions of the player.
- The player acknowledges that VWA is not responsible for the safety of the player or his property during the program or at any other time.
- The player acknowledges that nothing in these Terms & Conditions constitutes the relation of employer and employee and that he/she is not covered by worker's compensation insurance. The player may make his/her own arrangements in respect of insurance for personal injury or death and superannuation.
- The player indemnifies VWA and agrees to hold and keep indemnified VWA from all claims, actions, suits and proceedings whatsoever arising from any personal injury that the player may suffer as a result of competing throughout the program.
- The player hereby authorises and grants VWA or their sanctioned agents the right to use their name, voice, likeness and biographical material concerning them for the limited purposes of publicising, promoting and advertising the program, and for filming, televising and broadcasting, web casting, broadband and related IP/TCP internet presentations of the same.
- The player grants and assigns to VWA or their sanctioned agents the right to make use and show, from time to time and at it's discretion, motion pictures, live, taped or filmed television and video footage through any medium including digital and internet protocols of the player taken during the program without further compensation and hereby waive any right to such compensation for player and their heirs.
- By submitting a signed form, the player agrees to these Terms & Conditions, (& the relevant competition By-Laws.) The player understands that this is an agreement between themselves, VWA and their sanctioned agents to abide to these terms, and that they maybe subject to sanctions as outlined in relevant competition By-Laws the if they have been found to be in breach of these Terms & Conditions.
- The term of this Agreement shall be a period of player's membership duration.

By signing this Agreement form, I hereby agree to comply with the above Terms & Conditions, and the terms, conditions and rules outlined in the relevant VWA Competition By-Laws.
